## Information

- When ordering docu tools software on an annual basis, i.e. with a minimum term of one year, the customer cannot terminate the software usage agreement with docu tools GmbH within this minimum term and is obliged to pay the usage fee for the entire minimum term. The contract date is the date of signature of the order, which is renewed annually. If the software usage agreement with docu tools GmbH is not terminated in writing with two calendar weeks' notice to the next contract date, it shall be extended for another year.

Termination shall be effected by sending an email to [sales@docu-tools.com](mailto:sales@docu-tools.com), stating the intention to terminate the usage agreement.
